Karate After School Program (Free After School Pick Up from School)

Karate Class – Monday thru Thursday; Friday – Free Day

Parent Pick Up Time: Any time between 5:30PM and 6PM (\*Pickup after 6:15PM will be assessed a late fee -- \$1.00 every minute.)

▲ **One Time Activity Fee:** One Child -- \$125.00 (New Students)

Two Children -- \$199.00

Three Children -- \$249.00

Four Children -- \$260.00

Includes Uniform, T-Shirt, Belt, Karate Notebook

▲ **Weekly Fee** (3-5 days):

One Child -- \$ 65.00      Two Children -- \$110.00

Three Children -- \$160.00      Four Children -- \$195.00

▲ Payment is due **each** Friday **prior** to week of pick up. Student's fees that are not current **will not** be picked up until fees are brought current.

▲ Please notify the Karate school **in advance** when student is not to be picked up – **404-763-8939**.

(Note: If student already has Uniform/T-Shirt from Summer Camp, and new to Afterschool Karate Program, Registration Fee is \$65.00).

(If student was in the After School Program last year – Registration Fee is \$45.00).

▲ **Accepted Forms of Payment:** Cash, Credit Card (Visa, Master Card, American Express), Debit Card, \***Check** and Money Order

\*There is a **\$35.00 Fee** for each Returned Check – Payable the next day after notification by **cash, credit card or money order only. NO EXCEPTIONS!**

▲ Students participating in the After School Karate Program can also take the Saturday Karate Class from 12:00PM – 1:00 PM (No Charge)

▲ We also offer School's Out Day Camp – 7AM – 6PM & Early Release Pick Up (Add'l Fee is assessed for each – Inquire at Front Desk)

## REQUIREMENTS FOR PARTICIPATION IN AFTERSCHOOL KARATE PROGRAM

**REQUIRED:** Clean, Pressed Uniform, Karate T-Shirt, Belt everyday except Friday – T-Shirt Only on Friday.

**REQUIRED:** Student must stay in his/her seat and use Seat Belt at all times when riding on the Van(s) or any other designated Vehicle .

**REQUIRED:** No loud talking. No use of profanity or any other inappropriate language on van/vehicle or in the Karate school.

**REQUIRED:** No hitting or spitting on students, instructors or staff will be tolerated by any child. First time, warning. Second time, removal from program.

**REQUIRED:** Student must be respectful at all times to Instructors, Drivers, Staff, and to fellow students.

**REQUIRED:** Student must participate in Karate Class every day that he/she is present and be prepared to work hard and be serious.

**REQUIRED:** A written note must be provided by Parent/Guardian if child has any allergies to certain foods/snacks/beverages.

**REQUIRED:** A written note must be provided by Parent/Guardian if child is taking prescribed medication(s) or other medicines while attending Karate program.

**REQUIRED:** **Advance** notification must be given if child is not to be picked up from school on any given day(s). Failure to do so may result in an additional fee for unnecessary trip.

**REQUIRED:** Student must be in their school's designated area for Afterschool Pickups – Drivers cannot wait and look for student or return to school if child is left.

**NOTE: Continuous disruption and misconduct will result in disciplinary action at the discretion of Mr. Young and/or front office staff.**
